4 The following proof of registration of the Company must be produced **except items 6 & 7** before the Council may issue tender documents:

- (i) **Original Licence issued by UPKJ**
- (ii) **Valid Certificated Company Registration with Construction Industry Development Board (CIDB) for UPKJ Registered Contractor Works only**
- (iii) **Copy of Certificate of UPKJ Licence and Certificate of Company Registration with Construction Industry Development Board (CIDB) shall be submitted.**
- (iv) **All tender document must be collected by a Company's Director or Senior Officer with Letter Authorization from the Company and to bring along the Company's Chop.**
