1. The above vehicles/plant are available for viewing at Council’s Depot near Old Sibü Airport, Brooke Drive, Sibü.
2. Tender documents are obtainable either at **SMC Level 21, Landskap Section (River View Wing) or Ag. Municipal Secretary’s Office Level 23, Wisma Sanyan, Sibü** during office hours as stated below:-
Monday – Thursday : 8:00 a.m. - 12:00 noon
Friday : 8:00 a.m. - 11:00 a.m.
Monday - Friday : 2:15 p.m. - 3:30 p.m.
3. Upon payment of non-refundable tender document fee as specified above, whether in the form of cash/company cheque/bank draft or cashier’s order payable to '**SIBU MUNICIPAL COUNCIL**'
4. All tenderers are required to submit the refundable tender deposit as specified above in the form of Cashier’s Order or 'Bank Draft' only in favour of **SIBU MUNICIPAL COUNCIL** at the time of submission of the tender failing which shall result in disqualification of the tender.
5. Any tender delivered after the stipulated time on the ground of whatever cause shall not be considered.
6. The successful tenderer must make payment of the tendered sum to Council’s Treasury within one week’s time from the date of instruction in writing. In default of payment of the tendered sum within the period allowed, the tender deposit shall be forfeited.

The successful tenderer must remove/collect the vehicle/plant within two (2) weeks after payment of the tendered sum, duties, surtax and sales tax, if any, from the SMC Depot, Sibü. If he/they fail(s) to do so, Council reserves the right to forfeit his/their payment of the tendered sum and to recall tender and the default tenderer will have no claim whatsoever on the Council. The costs incurred in collection/removal of the vehicle/plant shall be borne by the successful tenderer.

All tenders must be submitted in a sealed envelope clearly marked ‘**TENDER FOR THE DISPOSAL OF USED VEHICLE/PLANT**’ and addressed to the Acting Municipal Secretary, Sibü Municipal Council, Level 23, Wisma Sanyan, No. 1, Jalan Sanyan, Sibü to reach him **not later than 12:00 noon on Thursday, 20.06.2019.**
9. The Council does not bind itself to accept the highest tender or any tender received nor shall it be responsible for any cost incurred by the tenderer.
